## **About the Presenters...**

Hon. Charles N. Clevert, Jr. (Ret.) provides a range of dispute resolution services as a mediator, arbitrator special master, and neutral evaluator with JAMS, the largest provider of ADR services in the world. Judge Clevert was Chief Judge of the United States Bankruptcy Court and later Chief Judge of the United States District Court for the Eastern District Court before joining JAMS where he has resolved a wide range cases, including commercial disputes, securities sales, malpractice, bankruptcy, international insolvency, wrongful death, police misconduct, civil rights, retaliation, wrongful discharge, discrimination, contract disputes, cryptocurrency, royalties, the Federal Rail Safety Act, the Americans with Disabilities Act, the Family Medical Leave Act, the Wisconsin Consumer Act and more. Judge Clevert, a graduate of the Georgetown University Law Center and Davis and Elkins College, is a member of the Wisconsin Bar Dispute Resolution Section Board and the Fellows of the Wisconsin Law Foundation Board.

Hon. David E. Jones, (Ret.), is a mediator/arbitrator/special referee with Resolute Systems and a AAA panel member.
