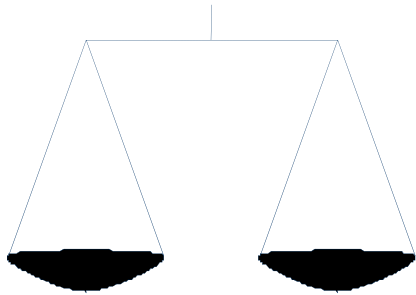

Our Courts Program

The Public Education Committee launched the Our Courts Program in 2013 aimed at providing nonpartisan informational programs to the public about Wisconsin state and federal courts.

Research commissioned by the State Bar in 2008, has shown that the more knowledge the public has about the courts system, the better the public's perceptions of the court. "Our Courts Wisconsin" is based on the successful "Our Courts" program developed by Colorado in 2007.

We are actively working on trying to create more awareness of this program throughout the state of Wisconsin. We are also reaching out to Judges and Attorneys to volunteer to become a presenter for the program in their areas, to become a presenter you must attend a speaker training session.
