Section Reports

The Administrative and Local Government Section partnered with PINNACLE on a September 19 program, "Administrative Law: Basics and Recent Developments 2023." Section members received \$20 off for in-person and webcast replays. The section hosted a networking lunch after the program. This seminar is available on webcast.

The **Elder Law and Special Needs Section** is co-producing their annual seminar with PINNACLE, "Legal Issues of the Aging" on September 22. This year's presentation features sessions on Medicaid estate recovery, income tax considerations for irrevocable trusts, and creating an accessible and inclusive practice. The section offered five scholarships to section members who were new to the practice area to encourage young attorneys to enter the practice. Section members enjoyed a networking lunch at the event. The **Environmental Law Section** held their "35th Annual Environmental Law Update" on September 14. Wisconsin Attorney General Josh Kaul spoke on environmental challenges in the state. Presentations covered updates on air, water and PFAS. The section provided five scholarships to members who are in their first five years or working for a non-profit or government agency. The **Family Law Section** hosted 154 attendees at the 42nd Family Law Workshop in Sturgeon Bay on August 10-12. Attendees had the option to attend a sunset trolley tour. The programming included a mental health professionals panel discussion on burnout in the legal profession, an introduction to DFS tools and calculators, and more.

The Intellectual Property & Technology Law Section held their 17th Annual Intellectual Property Academy in Lake Geneva on July 20 and 21. Attendees earned CLE credit in topics such as intellectual property management, technology transfer, ethics issues, IP asset valuations in business, artificial intelligence and patent research. Attendees also enjoyed a boat tour.

The Indian Law Section held their Eleventh Annual Indian Law CLE in Oneida/Green Bay on August 17 and 18. This CLE focused on two supreme court cases: *Brackeen v. Haaland* and *Lac Du Flambeau Band of Lake Superior Chippewa Indians et al. v. Coughlin.* Other topics included jurisdictional disputes, ethics in human resources, and avenues for tribal water protection. Approximately 70 people attended the CLE.

The **Young Lawyers Division** held its orientation and first board meeting of the year in August where they discussed goals for the upcoming year, including planning the 14th Annual Young Lawyers Conference which will be held on March 8, 2024, in Madison. Since June, communications have been distributed to members living in Colorado,Florida, Georgia, Hawaii, Illinois, Iowa, Tennessee, Mississippi and Vermont reminding them that WisLAP and Practice411 are available to them, as a member benefit, to help them cope with the challenges they are facing.

Committee Reports

The **Diversity Inclusion & Oversight Committee (DIOC)** recently welcomed new committee members Khalil Davis and Juan Ramirez. DIOC is maintaining open communication with Affinity Bar Leaders.

The **Diversity Counsel Program**, a working group of the Communication and Education Subcommittee, is developing a December program, "Unlocking the Power of Diversity: Effective Strategies for Retaining and Promoting Diverse Talent." The program will feature keynote speaker Sherri Ann Charleston, J.D., Ph.D., Harvard University's first Chief Diversity and Inclusion Officer. She is an alumn of U.W.-Madison Law School. Joining Dr. Charleston will be Judge Ashley Morse, Rock County Circuit Court. Judge Morse will be the panel moderator.

Law Student Outreach (LSO): The State Bar is committed to exposing law students to the benefits, services and experiences the State Bar offers to members so they will choose to practice law in Wisconsin and become active in the State Bar when they graduate. The group is working on new offerings to the Diversity Clerkship Program. Staff attended the New Student Orientation at Marquette. There were 196 1L students in attendance.

Data & Research, a subcommittee of the DIOC, is working to promote and retain diverse attorneys in the state, will be hosting a networking event for the law students. The first will be in Milwaukee in September and the second will be in Madison in March.

Legislature Fall Schedule Is Set

Beginning in September, the legislature resumes floor sessions and public hearings. Fall floor periods are scheduled from Sept. 12 through Sept. 21, Oct. 10 through Oct. 19, and Nov. 7 through Nov. 16. After that, the legislature will break and return Jan. 16, 2024, for the start of the spring floor period. In between floor periods, both chambers will hold committees on legislation, giving the public the opportunity to weigh-in on legislation.

Grassroots Advocacy Key to Educating Lawmakers, Passing Bills

The continued grassroots support of our State Bar Board of Governors, their colleagues and constitutents is critical this fall as the Advocacy and Access to Justice Team works to educate lawmakers on expungement reform, returning 17-year-olds to juvenile criminal courts, and the rural attorney shortage issue.

Please send a message through the **State Bar Advocacy Network**. You can use a prewritten message or write your own message. Either way, we've made it easy. If you have already sent a message, we encourage you to send a follow up.

Expungement reform, introduced this session as **AB 37** and **SB 38**, faces similar challenges and headwinds as in previous years. In past sessions, the Assembly overwhelmingly passed the legislation, but struggled to receive the same support in the Senate. If this session is to be different, it will require grassroots support from State Bar members. One way to make an impact on this bill is to reach out to State Bar Advocacy staff and coordinate with your colleagues living in key state Senate districts.

The issue of **returning 17-year-olds to juvenile jurisdiction** courts seems to be gaining some traction, with a bill expected to be introduced sometime this fall. Of course, introducing a bill is by no means an indication of whether it will pass, and the State Bar will be working to generate grassroots support for this topic. Be on the lookout for "action alert" emails to help amplify and coordinate the voice of the legal profession on this topic.

Other grassroots advocacy highlights: a new **civil legal aid** action alert was sent to all members and partner organizations of the Civil Legal Aid Alliance of Wisconsin on June 13. It was targeted to all 16 legislators serving on the Joint Finance Committee, urging them to vote for a motion to make a substantial increase in civil legal aid funding. A similarly targeted message was sent to members of the Joint Finance Committee asking them to include modest funding for the Judicial Council.

Celebrating Lawyers For Their Pro Bono Work

The **Pro Bono Honor Society** and the State Bar of Wisconsin recognized 296 lawyers who donated at least 50 hours of pro bono service in 2022. That adds up to at least 14,800 hours. Consumer Protection Program Updates

The Fee Arbitration Program will be training new volunteer panelists on September 27. When disputes occur, two or three trained arbitrators listen to arguments presented by both sides. The decisions made are final and binding, subject only to the appeal rights under Chapter 788, Wisconsin statues. Panelists may be lawyers and members of the public.

The Wisconsin Lawyer's Fund for Client Protection is designed to provide reimbursement to clients who have incurred financial losses due to dishonest conduct of their attorneys. Volunteers will be considering at least 26 applications at the committee's October 3 meeting.

Law Foundation Ends Fiscal Year Strong

Thanks to our generous donors, the Wisconsin Law Foundation ended the Fiscal Year 2023 strong, with a surge of donations coming in via membership dues thanks to our "Every Member Every Year" campaign.

Donations were significantly up, while operating expenses came in under budget. In addition, investment income dramatically increased in the final quarter, with a record amount in grants continuing to expand donors' impact.

With both fundraising and investments combined, the Law Foundation's total assets grew \$302,752 this year, a 12% increase over FY22.

On behalf of our donors, the Law Foundation distributed a record \$67,563 in scholarships, awards and grants to organizations, programs, and services across the state. In 2024, the Foundation will extend \$70,536. To give you a sense of the growth in impact, the Foundation awarded \$26,782 in 2013. That was the first year in which the Foundation implemented a policy of spending no more than 4% of the Law Foundation's corpus.

This allows the Foundation to grow and move toward a fully sustainable funding model. The last decade's steady growth in distributions demonstrates the wisdom and value of this approach.

Thank you to donors throughout the year who continue to move the Wisconsin Law Foundation's mission and work forward.

The Annual Wisconsin Law Foundation Fellows Recognition Dinner is set for Tuesday, October 10, 2023, at Monona Terrace in Madison. The Fellows will honor new inductees and present the Charles L. The Fellows program recognizes State Bar members who have demonstrated outstanding legal ability and devotion to the wellbeing of their community, state, and nation, as well as to the advancement of the legal profession. Opportunity to join the Fellows is limited to 2.5% of the State Bar's total membership and is extended, by nomination, to only to a limited number of Wisconsin lawyers each year.

Now Is the Time To Explore Health Insurance Rates

With increasing wages, inflation, medical utilization, and sky-rocketing pharmaceutical costs, health care coverage premiums continue to rise. According to the Kaiser Family Foundation, small employers continue exploring alternative health care options and the percentage of workers covered by these alternative arrangements has increased from 21% in 2019 to 41% in 2022.^[11] Before reducing coverage, decreasing employer contributions, or eliminating coverage completely for attorneys and law firm staff, consider exploring the State Bar's group health plan for law firms as a cost-saving option.

The group health plan for law firms provides another option to consider in offering health care options to attorneys and staff. November's open enrollment timeframe brings this topic to the forefront, but law firms can enroll in this group health plan at any time throughout the year, not just during the open-enrollment period. Coverage is provided by Wisconsin Physicians Service Insurance Corporation (a/k/a WPS, WPS Health Insurance).

State Bar Meetings: New Registration Tool Coming Soon

The State Bar is developing a new way for members to RSVP for non-fee meetings online via Marketplace. Here is how it will work:

- Members will receive an email notification of their meeting with a link to Marketplace where they will register. It will have a similar look as the State Bar Seminars registration page.
- The member (who is qualified to attend a board or committee meeting) will be able to step through and select their Attending/Attending Virtual/Not Attending response and other options, then complete the registration for \$0.
- Members will have a secure option for their administrative assistant to register for meetings on their behalf, if they wish.
- If there is a fee associated with a meeting, the member will be able to pay for it by debit or credit card.

This pilot project is undergoing rigorous testing. Once complete, staff will be trained to use it for meetings.
