# **Our Courts Wisconsin Programs**

*Lincoln's Legacy* — This essay was written by Hon. Russell E. Carparelli, a Colorado Court of Appeals judge since 2003, with the collaboration of the Colorado Judicial Commission and *Our Courts Colorado*. We do not speak of Abraham Lincoln as one of our nation's Founders, yet we owe him an incalculable debt of gratitude for his commitment to the principles of equality and liberty stated in the Declaration of Independence and for transforming the Constitution to give those principles the power of law.

This humorous presentation will help audiences understand the judicial system through excerpts from various pop culture depictions of court proceedings. The entertainment industry often presents an unrealistic and unflattering view of what happens in the courtroom, and this program aims to correct some of the misinformation. From Judge Judy to John Grisham, we'll be separating myth from reality and learning more about the court system along the way.

#### Understanding the Criminal Court Process: Protecting the Rights of Wisconsin Citizens —

This basic level presentation will provide an overview of the criminal court proceedings. The focus is to review the most common terms used and how the process works. Topics may include discussion on: 1) types of charges; 2) the role of the judge, district attorney, public defender, jury; 3) the various stages of a criminal proceeding, from pre-trial hearings to plea bargaining or trial to sentencing; 4) the preservation of rights throughout the process; and 5) appropriate courtroom behavior.

Courts are an essential part of our democracy and provide balance in our government. Fair and impartial courts are the cornerstone of our system of justice.
