OWI SENTENCING GUIDELINES EFFECTIVE 07-07-2023

(These guidelines are offered to promote consistency among the circuit court branches of the Seventh Judicial Administrative District. They are not intended to govern the decision of the court to utilize any prescribed penalty available under the law. The court is free in its discretion to depart from the guidelines.)

PENALTY RANGE: (§346.65(2)(am)1)

FORFEITURE: \$150 to \$300 (plus costs & surcharges)

REVOCAATION: 6 – 9 Months (Occupational - no waiting period; (§343.30(1q)(b)2)).

IGNITION INTERLOCK: Mandatory interlock for all alcohol concentration of .15 or more. License restricted to interlocked vehicles, plus all registered and titled vehicles (unless excepted) for period a of one year (§343.301(2m)) beginning when license is issued. \$50.00 interlock surcharge.

PROBATION: 6-24 Months

IGNITION INTERLOCK: Mandatory interlock. License restricted to interlocked vehicles, plus all registered and titled vehicles (unless excepted) for period of one year to 36 months beginning when license issued. \$50.00 interlock surcharge.
