On Friday, April 12 from 7:00 - 9:00 p.m. in the Supreme Court Hearing Room (231 East Capitol) the Janesville Performing Arts Center, the Offices of the Chief Justice and the Director of State Courts will host a reading of a new play about the life of Lavinia Goodell, Wisconsin's first woman attorney, who was admitted to the Rock County Bar in 1874 and to the Wisconsin Supreme Court Bar in 1877. A Wisconsin playwright is developing the play and had access to her papers, diaries and letters from Berea College in Kentucky. It's a work-in-progress, and part of the process is to hold public readings. This will be free and open to the public.
