

My name is Ben Evans. I am a member of the Wisconsin State Bar Public Education Committee and am reaching out to make your group aware of a new program being implemented by the Wisconsin State Bar. The program is entitled Credit Abuse Resistance Education (CARE).

The CARE program relies on volunteer attorneys and judges to educate students and adults on the responsible use of credit and other fundamentals of financial literacy. This program has been implemented in other areas of the country, and the Wisconsin State Bar is now trying to streamline and promote the program here in Wisconsin.
