Additionally, she served as a loaned executive for the United Way of Dane County. In every position, Williams has focused on expanding access, building equity, and challenging institutional norms.

In addition to her professional accomplishments, Williams generously shares her expertise through service to organizations including the YWCA Madison, Governor's Equity & Inclusion Advisory Council, State Public Defender's Office Board of Directors and the Wisconsin Women's Network.
