## WisLawHelp.org honored as Pro Bono Organization of the Year for transforming legal aid access

MADISON, Wis. (April 22, 2024) -- WisLawHelp.org, spearheaded by Judicare Legal Aid in Wausau, has been named the Pro Bono Organization of the Year by the [State Bar of Wisconsin](#) Legal Assistance Committee. This award recognizes the platform's outstanding contribution to enhancing access to legal services for low-income individuals across the state.

Launched in mid-2024, WisLawHelp.org serves as a comprehensive statewide triage and referral system, simplifying the process for individuals seeking legal assistance. The platform offers user-friendly access to resources and referrals for various legal issues, including housing, family law, and consumer rights. By centralizing information and tailoring it to meet the needs of Wisconsin residents, especially in underserved areas, [WisLawHelp.org](#) bridges a critical gap in legal aid accessibility.

WisLawHelp is currently managed by [Judicare Legal Aid](#), a Wisconsin legal aid organization committed to providing free civil legal help to those who cannot otherwise afford it. Judicare Legal Aid collaborates widely, including with Legal Action of Wisconsin, LIFT Wisconsin, the University of Wisconsin Law School, the Wisconsin State Law Library, the Wisconsin Trust Account Foundation, the Wisconsin Equal Justice Fund, the Wisconsin Access to Justice Commission, the Marquette Volunteer Legal Clinic, and the Milwaukee Justice Center.

The Pro Bono Organization of the Year Award is presented annually to a law firm or organization that demonstrates dedication to the development and delivery of legal services to the poor or has contributed significantly toward developing innovative ways to deliver volunteer legal services.



WisLawHelp.org, a statewide legal triage and referral platform led by Judicare Legal Aid, has been named the Pro Bono Organization of the Year by the State Bar of Wisconsin Legal Assistance Committee. The award honors WisLawHelp.org's innovative role in expanding access to legal services for low-income residents across Wisconsin.
