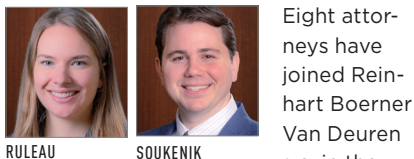
Schanowski previously worked as a prosecutor at the Cook County State's Attorney's Office and as an employment litigator.
