# **Character and Fitness Screening & the Wisconsin Lawyers Assistance Program**

Most of you are aware of the character and fitness screening process when applying for the bar examination. Like applying to law school, this is a time to be completely open and honest with the Board of Bar Examiners (BBE) about conduct that could potentially adversely affect your ability to practice law. Here's how the <u>State Bar of Wisconsin Lawyers Assistance Program</u> (WisLAP) can help you with this process, should you have reasons to disclose.

"Within the past seven years have you ever cited physical or mental illness, or an emotional, nervous or behavioral disorder as an explanation for your poor academic or professional performance?"

That is a question from the <u>BBE's character and fitness application</u>. The best thing you can do is be completely honest about past conduct. I've heard more than one student tell me they didn't report something because they didn't think it would be discovered. Trust me when I tell you, it *will* be discovered. What happens when you're not forthcoming and the BBE finds out on their own is a candor problem. Now, in the eyes of the BBE, you're seen as a liar or someone trying to hide things. Someone that can't be trusted. Understandably, this makes it very hard for them to incontestably recommend you to be a lawyer. Typically, the indiscretion will not be a bigger hindrance to your application than the withholding of the indiscretion.

WisLAP can help you with this process by documenting your steps toward sobriety and rehabilitation. If, for example, you know that as a 1L you have one or more OWIs, it makes sense to contact WisLAP right away, and voluntarily start our monitoring program. When you're

ready to apply to the bar, you will have had at least three years of documented proof that you've got things under control.

There is no guarantee that WisLAP can always help in these matters. Some situations get out of our control prior to contacting us. That's why it's important to call us early. However, if it's not early and you do feel like things are past out of control, call us anyway. We never turn away lawyers, law students, or judges that need our help.
