Office of Lawyer Regulation

The Wisconsin Supreme Court has authority over all attorneys licensed to practice law in the State of Wisconsin. The lawyer regulation system was established to carry out the Supreme Court's constitutional responsibility to supervise the practice of law and protect the public from misconduct by persons practicing law in Wisconsin. The Office of Lawyer Regulation is responsible for investigating attorneys who may have violated the rules governing attorney conduct.
