About the Keynote:



Hon. Mary E. Triggiano

Judge Triggiano is the Director of the Andrew Center for Restorative Justice and Adjunct Professor of Law at Marquette University Law School. She teaches Restorative Justice and the Restorative Justice Clinical Program. From 2017-2020, Judge Triggiano, as an Adjunct Professor at Marquette Law School, co-taught *Problem-Solving Courts, and the Neuroscience of Trauma*. This workshop included teachings on restorative justice, trauma, and trauma-informed care.

Prior to joining the Law School, she was the Chief Judge for District 1 Circuit Court. Governor Doyle appointed her to the bench in 2004. She was assigned first to the Children's Division from August 2004 to August 2009. It was there that she became interested in restorative justice, participating in Justice Geske's restorative justice circles at Green Bay Correctional and helping to implement victim offender dialogues with youth charged with crimes in Milwaukee. She was next assigned to the Domestic Violence Court, later returning to Children's Court where she led the Family Drug Treatment Court and created the first of its kind in Wisconsin Healthy Infant Court. Her last assignment was the Civil Division. She was a Deputy Chief Judge for Chief Judge Maxine White for over four years until becoming Chief Judge in February 2020.

Prior to becoming a judge, she served as managing attorney for Legal Action of Wisconsin from 1994-2004. She also was an associate attorney in the litigation department at Reinhart. Boerner from 1988 to 1994.

Over the past 30 years, she has taught numerous topics to the judiciary, attorneys, medical professionals, academia, students, and others. The topics included, but were not limited to: Restorative Justice, Trauma-Informed Care, Childhood Trauma, Child Welfare Law, Problem-Solving Courts, Evidence-Based Sentencing Practices, View from the Bench, and Domestic Violence.

At Marquette Law School she was responsible for all aspects of Marquette University Law School's nationally ranked dispute resolution program and supervised the Small Claims Mediation clinic.

She earned her J.D. from the University of Wisconsin Law School, where she participated on the Moot Court Board. She received a Graduate Certificate in Dispute Resolution from Marquette University in 1997. Ms. Fleury was a past-Chair of the Wisconsin State Bar Section Leader's Council, past- chair of the Wisconsin State Bar's Alternative Dispute Resolution Board, past co-chair of the Association for Conflict Resolution's Consumer Section, and a member of the American Bar Association Dispute Resolution Section.

Hon. Pedro A. Colón is an Appellate Judge, Court of Appeals - District 1 (11/2023-present), Milwaukee County Circuit Court Judge (2010-11/2023), Wisconsin State Legislature (1999-2010), Joint Committee on Finance (2006-10), Judiciary Committee (1999-08), Private Practice (1994-2006), Milwaukee Metropolitan Sewage District, Commissioner (2006-10), Milwaukee Area Technical College, Board Member (2004-08).

Hon. Jorge Fragoso Gov. Evers appointed Jorge Fragoso to the Milwaukee County Circuit Court – Branch 23 to fill the vacancy created by Judge Lindsey Grady’s resignation. Fragoso assumed office on November 4, 2023 and his current term ends on August 1, 2030.

Since 2021, Fragoso had been an associate at Gimbel, Reilly, Guerin & Brown LLP, focusing on criminal defense, appeals, and civil litigation. He began his legal career as an assistant state public defender in Waukesha County, representing indigent clients as a trial lawyer and serving as a member of the drug and alcohol treatment courts. In

2016, he moved to the public defender’s appellate division in Milwaukee, handling postconviction matters and criminal appeals. Throughout his career, he has participated in numerous oral arguments in front of the Wisconsin Supreme Court.

Fragoso is a graduate of the University of Notre Dame and the University of Wisconsin Law School. He served as a member of the Wisconsin Criminal Justice Coordinating Council from 2019 to 2021, has volunteered with both the Marquette Volunteer Legal Clinic and Big Brothers, Big Sisters of Milwaukee, and is an active member of the Wisconsin Hispanic Lawyers Association.



Hon. Jacob Frost is a judge for the Dane County Circuit Court of Wisconsin. He was appointed by Governor Tony Evers on July 4, 2020, filling a vacancy created by the retirement of Hon. Richard Niess.

Frost earned a bachelor's degree in German and political science from the University of Wisconsin, Madison in 2007. He then completed J.D. at the University of Wisconsin Law School in 2010.

After graduation from law school, Frost entered into private practice. He started as an associate at Boardman Clark in Madison, rising through the ranks to become a partner in 2017. During his tenure there, Frost represented individuals and businesses in a wide range of legal matters, including commercial and personal litigation, debt collection, landlord tenant law, and family law. His focus, however, was on several unique industries, such as the banking and dealership industries.

Frost sat on the Board of Access to Independence, a nonprofit organization dedicated to providing resources, services, and advocacy for people with any type of disability.



Hon. Amber Raffet August is a dedicated and respected public servant currently serving as the Circuit Court Judge for Branch 14 in Milwaukee. Appointed to this role by Governor Tony Evers, she brings more than a decade of legal experience and an unwavering commitment to justice, fairness, and community service to her position.

Judge Raffet August began her legal career at Grzeca Law Group, and immigration law firm based in Milwaukee. She then transitioned to RISE Law Center, where she tirelessly represented survivors of violence in family law and immigration proceedings. Her passion for family law led her to the Legal Aid Society of Milwaukee, where she advocated for the best interests of children from indigent families during family court litigation.

Prior to her appointment as Circuit Court Judge, she served as an Assistant Family court Commissioner for Milwaukee County. In this role, she presided over a range of family court proceedings, demonstrating exceptional legal acumen and real empathy for those she represented.
